## **Regular Business**

The Board of Education approved the agenda, as presented.

The Board interviewed Alejandro (Alex) Gonzalez, a Charlotte resident, to fill the vacancy on the Eaton RESA Board of Education as created by the resignation of President Max Baxter.

Alejandro (Alex) Gonzalez took the Oath of Office to serve on the Eaton RESA Board of Education.

The Board approved the mid-term appointment of Alejandro (Alex) Gonzalez as Eaton RESA Board Trustee through June 30, 2023, as presented.

The board accepted nominations for re-election of Board officers for 2021-22 due to the vacancy and subsequent vacancies as a result of the resignation of Eaton RESA Board of Education President Max Baxter.
